ARTFEST™ 2019 OF SCOTTSDALE- MUSIC BOOTH RULES AND REGULATIONS

1. Musicians must personally attend his/her exhibit and be present during the entire two days of the Festival.
*Representatives may not attend in place of the musician. Andrew Maguire & Associates, LLC. reserves the right to request photo identification to ensure compliance with this rule. (*exceptions to this rule may only be granted through the express written authorization of the Festival Director.)
2. The music performed and sold must be consistent with samples submitted by the musician and with **ArtFest™** guidelines. Andrew Maguire & Associates, LLC. has the right to require that any other music be immediately stopped at the show. Failure to comply may result in musician's removal from the festival and musician's opportunity to exhibit in future festivals.
3. All music performed and sold **must be original** and produced by the musician.
4. A copy of all music to be performed and/or sold must be on file with "agent" Andrew Maguire & Associates, LLC.
5. Musician must perform a minimum of seventy percent (70%) of the time during official Festival hours.
6. It is Andrew Maguire & Associates, LLC sole obligation to furnish assigned exhibit space plus general cleaning and guard service. Services of any other nature shall be requested by the musician in writing at least 30 days prior to the festival.
7. Musician shall be liable for delivery, handling, erection and removal of musician's displays and materials. All pertinent fire codes, laws, ordinances and regulation pertaining to health, fire prevention and public safety shall be strictly obeyed. Nothing shall be nailed, stapled, taped or otherwise affixed to the wall, the ground or any part of the exhibition area in such a way to damage the area.
8. Andrew Maguire & Associates, LLC. prohibits the installation and operation of any exhibits not meeting its approval. Andrew Maguire & Associates, LLC., in its sole discretion, may prohibit the conduct of any activity whatsoever which it deems deleterious and not in the best interest of the festival.
9. **Set-up** for the Festival may begin when all spaces in your area are marked correctly and approved by the Director. Due to parking restrictions during Festival hours, set-up must be completed and all vehicles removed by **9AM Saturday morning**. After 9AM it will be necessary for you to park outside the Festival area and carry your display in.
10. **Takedown!** To facilitate clean up and the needs of the government offices on Monday in the Scottsdale Civic Center Plaza, all booths must be removed from the premises by **midnight on Sunday evening**. **No exceptions!** Please let the Festival staff know if you need assistance.
11. Andrew Maguire & Associates, LLC. will not be liable for refunds or any other liabilities whatsoever, for failure to fulfill these terms and conditions, due to the unusable condition of the area in which the festival is to be produced, caused by, but not limited to, fire or other calamity, any act of God, public enemy, strikes, statutes, ordinances of any legal authority, or any cause beyond Andrew Maguire & Associates, LLC's control. Insurance, if desired by musician, must be obtained by and at musician's expense. Andrew Maguire & Associates, LLC assumes no risk.
12. Musician, by signing the Musical Sales Application, will hereby release and forever discharge ArtFest™ of Scottsdale, Andrew Maguire & Associates, LLC the City of Scottsdale, et al, the Scottsdale Cultural Council, and all sponsoring organizations and their directors, officers, employees, agents and volunteers from any responsibility, personal liability, claims, loss or damage arising out of or in conjunction with his/her participation in **ArtFest™ of Scottsdale**. Andrew Maguire & Associates, LLC. will not be responsible for any injury sustained by the musician and guests while within space designated for exhibits. Further, musician understands that he/she stores his/her music and equipment at his/her own risk.
13. No waivers, modifications or amendments shall be valid unless approved in writing by the Director of **ArtFest™ of Scottsdale**. Venue for all legal proceedings arising from violations of these terms and conditions must be initiated in Maricopa County, Arizona.
14. **NO FEES WILL BE REFUNDED AFTER ACCEPTANCE**. All cancellations must be received in writing. There is a \$45.00 fee for all returned checks.

FESTIVAL FEES:

PERFORMANCE SALES FEE is \$200 (please submit payment with application).

IN ADDITION, on gross sales over the amount of \$3,000.00, for both Saturday and Sunday, a five-percent (5%) fee will be due and payable at the end of the Festival day on Sunday, after close of event at the Festival Headquarters. ** EXAMPLE: \$4,000 (Gross sales for Saturday and Sunday) - \$3,000 = \$1,000 x 5% = \$50.00 (amount of fee due.)

A SECURITY DEPOSIT CHECK OR CHARGE in the amount of \$100.00 must be enclosed with the signed application/agreement. Deposit check will be returned when all fees due to Andrew Maguire & Associates, LLC. are paid in full and musician space is cleared and clean of all equipment, supplies, products, etc.
